	Answer: No. the Companies expenditure requirements now consist of corporate overhead and administrative costs which are kept to a minimum. The company has completed its initial phase 1 drilling program which forms the bulk of the capitalised exploration costs noted at item 8.2.

	Answer: No. The Company has no plans to raise any capital in the short to medium term outlook.
